Provided, however, that nothing herein shall be construed to be a waiver of the County's sovereign immunity, provided by the Florida Constitution of provisions of Section 768.28 Fla. Stat. (2003).

By applying, each vendor agrees to accept the following rules:

1. Work must be confined to the assigned space. Chamber officials reserve the right to enforce the 10' x 10' space size.
2. Do not set up in an unassigned space without approval from a Hobe Sound BBQ Festival Committee official.
3. Setup and break down times will be sent after approval to be a vendor.
4. NO CONSUMPTION OF ALCOHOLIC BEVERAGES BY VENDORS. Any vendor seen drinking alcoholic beverages at their location during event hours will be asked to leave immediately
5. The VENDOR shall be solely responsible for his/her own display, materials and products; set up and dismantling and understands and agrees that the HSCC, Martin County, or the property owner of the land on which the exhibit is erected, its agents, employees and representatives provide no guarantee for the safety of the VENDOR'S property and shall have no obligation or be responsible for any damage to the VENDOR'S display, material, work or equipment.
6. Nails may not be placed in the streets, sidewalks, or parking lots.
7. No loose wires may be placed on pedestrian walkways.
8. VENDORS bear the responsibility for security needs for their exhibit.
9. VENDOR is responsible for collecting sales tax.
10. VENDORS are responsible for licensing as may be required by local and state governments and all pertinent laws, codes and regulations of authorities/government having jurisdiction
11. Not provided -- Tents, extension cords, lighting fixtures, table skirting, tables or chairs.
12. The VENDOR shall leave with all of their unsold items, merchandise, trash, and boxes.
13. VENDOR must clean their designated exhibit area. Any items left by the VENDOR or not removed by 9 pm , Saturday, July 9, shall be deemed abandoned and may be disposed of by the Hobe Sound Chamber of Commerce at its own discretion.
14. The VENDOR shall arrange its exhibit so as to not interfere or obscure a neighboring VENDOR'S exhibit.
15. The VENDOR agrees to follow any and all instructions provide by Hobe Sound Chamber of Commerce or Martin County or its representatives, agents and employees relative to the VENDOR'S display, its set up and its dismantling.
16. Displays will be viewed by Hobe Sound Chamber of Commerce officials who have sole discretion to require the removal of exhibits or products that violate event guidelines or are deemed unacceptable.
17. The VENDOR understands and agrees that their participation shall not constitute nor be an advertisement for a specific business, service, association, club, or product.
18. The VENDOR understands and unconditionally agrees that in order to participate, it shall not display and/or offer for sale art work or material the Hobe Sound Chamber of Commerce (in its sole discretion and interpretation) deems offensive or which is deemed not in keeping with the family character of the event. Any offensive art work or material must be immediately removed from its display. Failure to do so obligates the VENDOR to immediately dismantle its display and vacate the designated area. Hobe Sound Chamber of Commerce officials reserve the right and the VENDOR authorizes Hobe Sound Chamber of Commerce officials to remove the offensive work from display and to hold without concern or responsibility for its welfare, until the conclusion of the event, at which time the VENDOR may retrieve the art/material.
19. VENDOR may not assign its right to the exhibit space without the express written authorization of Hobe Sound Chamber of Commerce officials.
20. The VENDOR understands that the submission of a written request is not a guarantee that the request will be accepted.
21. The VENDOR represents that he/she accepts and will comply with these guidelines, rules and regulations through its own free will, that he/she understands the guidelines, rules and regulations, believes them to be fair, beneficial and in its best interest and agrees to be bound by the same. The Hobe Sound Chamber of Commerce reserves the right to amend the agreement, rules and regulations when deemed necessary to be in the best interest of the event.
